2	<p>Community Pathways <i>Geoff Lundie-Jenkins</i></p> <ul style="list-style-type: none">• DES presented an overview of the proposed Community Pathways process for mapping revisions.• The Community Pathways is an avenue for members of the community and local governments to identify areas that they believe warrant consideration for inclusion as a koala habitat area. This process is in addition to the existing process to allow a landholders to make, amend or revoke koala habitat areas on their properties.• The proposed process utilises the existing Head of Power under the Nature Conservation (Koala) Conservation Plan 2017 for the Chief Executive to make a map of Koala Habitat Areas based on information which is readily available (such as sightings data) and would link to the proposed annual revision of the Koala Habitat Area Map.• This proposal has been provided to South East Queensland local governments for feedback and the process has been reviewed iteratively in response to this feedback.• A Koala Technical Advisory Group will be established to support this process.• Council members provided feedback on the process for inclusion in the final version, including the need to simplify the flowchart for public release, the need to manage expectations of submitters, and support for amendments to be part of the annual updates to the koala habitat map.• Council members requested clarification on the proposed consultation process and timeframes ahead of the annual mapping review each year, specifically the role of the Planning Group (Queensland Treasury) and the Koala Advisory Council.• The table below outlines the resolutions on the Community Pathways proposal: <table border="1"><tr><td>KAC:</td></tr><tr><td>2.1 Noted the proposed Community Pathways</td></tr></table>	KAC:	2.1 Noted the proposed Community Pathways

Locally Refined Koala Habitat Areas (LRKHA)

- DES and the Queensland Herbarium presented an update on the review and rationale of the LRKHA that is underway using the updated mapping for high value regrowth vegetation that is now available.
- This work is being undertaken in response to feedback from local governments and the community that there are additional areas known to contain koalas, but those areas are not included in the koala habitat map.
- Detailed work has commenced with Moreton Bay Regional Council to review the LRKHA and all South East Queensland local governments have been consulted on the update process, DES will continue to work with local governments over the coming months.
- Council members provided feedback on the need to consider how previously protected areas that are being incorporated into LRKHA revisions are to be reported against the target for a net gain in koala habitat.

- LGAQ requested representation on the Local Government Working Group, and suggested the group should include 2 representatives from each SEQ local government (i.e. one member for each particular area of interest - planning related issues and environment related issues).
- The revised targets included in the SEQ Koala Conservation Strategy have been developed in consultation with Council members, and considered to be clear, realistic, measurable and time bound target.
- Council members supported involvement in the groups, including receiving copies of meeting minutes
