**CUMULATIVE MANAGEMENT AREA
DECLARATION NOTICE (No 01) 2011**

Short title

1. This notice may be cited as the Cumulative Management Area Declaration *Notice (No 01) 2011*.

Declaration of cumulative management area [s.365 of the Act]

2. Pursuant to section 365 of the Act, the chief executive declares the area described in item 3 to be a cumulative management area.

3. The boundary of the cumulative management area is as follows:

- **Commencing** at the southern most western corner at 148° 05' 04.1202" East and 28° 29' 54.3826" South
- **Thence** by a line to 148° 05' 04.0427" East and 26° 14' 54.3711" South
- **Thence** by a line to 147° 50' 04.0298" East and 26° 14' 54.3770" South
- **Thence** by a line to 147° 50' 03.9575" East and 23° 24' 54.4283" South
- **Thence** by a line to 148° 10' 03.9408" East and 23° 24' 54.4241" South
- **Thence** by a line to 148° 10' 03.9378" East and 23° 19' 54.4260" South
- **Thence** by a line to 148° 25' 03.9300" East and 23° 19' 54.4214" South
- **Thence** by a line to 148° 25' 03.9244" East and 23° 09' 54.4246" South
- **Thence** by a line to 149° 35' 03.8863" East and 23° 09' 54.3888" South
- **Thence** by a line to 149° 35' 03.9301" East and 25° 19' 54.3667" South
- **Thence** by a line to 150° 40' 03.8818" East and 25° 19' 54.3216" South
- **Thence** by a line to 150° 40' 03.9095" East and 26° 09' 54.3306" South
- **Thence** by a line to 151° 15' 03.8795" East and 26° 09' 54.3302" South
- **Thence** by a line to 151° 15' 03.8935" East and 26° 39' 54.3400" South
- **Thence** by a line to 151° 45' 03.8697" East and 26° 39' 54.3346" South
- **Thence** by a line to 151° 45' 03.8867" East and 27° 09' 54.3311" South
- **Thence** by a line to 152° 00' 03.8725" East and 27° 09' 54.3235" South
- **Thence** by a line to 152° 00' 03.9042" East and 28° 09' 54.3121" South
- **Thence** by a line to 151° 30' 03.9360" East and 28° 09' 54.3267" South
- **Thence** by a line to 151° 30' 03.9438" East and 28° 29' 54.3202" South
- **Thence** by a line to the point of commencement at, 148° 05' 04.1202" East and 28° 29' 54.3826" South.

4. The cumulative management area described above is intended to align with the external boundary of a subset of blocks (described under section 29 of the *Petroleum and Gas (Production and Safety) Act 2004*). The initial latitudes and longitudes described under this section were converted to the Geocentric Datum of Australia 94 and then rounded to four decimal seconds.

5. The area declared in this notice may be referred to as the Surat Cumulative Management Area.
