**Environmental Protection Regulation 2019** 

## Fees for permits for environmentally relevant activities (ERAs)

This information sheet provides details on the processes and fees involved in applying for, or making a change to, a permit (environmental authority) for undertaking an environmentally relevant activity (ERA) in accordance with the provisions of the Planning Act 2016 and Environmental Protection Act 1994.

#### Forms and fees for environmental authorities

You will need to submit application forms and pay application fees if you want to conduct activities requiring an environmental authority in Queensland.

You can use the form and fee finder to work out what forms to use and whether any fees are payable. To access this tool, go to <a href="www.business.qld.gov.au">www.business.qld.gov.au</a> and use 'Forms and fees for environmental authorities' as the search term. A copy of the content has been included in the table below.

The forms and fees in the table below are for environmental authorities (EA) where the administering authority is the Department of Environment, Science and Innovation (DESI) or Department of Agriculture and Fisheries (DAF). You can use these forms to apply for, comply with and make changes to your EA. The table has details of where the forms can be obtained. Where there is no publication number listed, there is no template required i.e. does not need to be done in a set format.

Certain applications to DESI can be made using DESI's digital platform Online Services. Forms for applications that cannot be made using Online Services are available at <a href="www.qld.gov.au">www.qld.gov.au</a> using the publication number as a search term.

If you do not want to apply using Online Services or DAF is the administering authority for the application, the application form is available at <a href="https://www.qld.gov.au">www.qld.gov.au</a> using the publication number as a search term.

If a local government is your administering authority, you will need to contact them about the relevant forms and fees. You can use the local government directory to find these contact details. The local government directory can be accessed at <a href="https://www.statedevelopment.qld.gov.au">https://www.statedevelopment.qld.gov.au</a> using 'local government directory' as a search term.

If your activity triggers a material change of use for an environmentally relevant activity, you will need to make a development application through State Assessment and Referral Agency (SARA). Application can be lodged at <a href="https://planning.statedevelopment.gld.gov.au">https://planning.statedevelopment.gld.gov.au</a>.
